### **Registration Information (12:00 on Saturday):**

- **Pre-Registered** applicants (those who have turned in the application prior to March 16th) will receive the choice of contestant numbers.
- **Applicants not pre-registered** need to bring a completed application packet to registration on the day of auditions. It is recommended that walk-ups arrive promptly at noon to ensure sufficient time to register.
  - Include cash or money order for the registration fee (\$25.00) payable to the Arizona Cardinals. Checks will not be accepted.
  - Include a non returnable recent photo with application (minimum size 5x7)
- Applicants must be 18 years of age as of May 1, 2012. All applicants must bring a valid government issued photo ID with them to the audition. Applicants who are not of age will need the waiver signed by a parent or guardian.

### **Commitment Information**

Members of the 2012 Cheerleading team must meet the following requirements

- All applicants
  - Must have a full time job or be a full time student
  - Must be available for practices at the Cardinals training facility on Tuesdays and Thursdays (6:30-9:30 p.m.).
  - Must have a reliable source of transportation to all practices and events
  - Must be at least 18 years of age by May 1, 2012
- Members of the 2012 cheerleading squad will be required to make a year long commitment and sign a contract committing time through to May 2013
- All 2012 members must be available for the following mandatory events
  - Draft day practice- April 5<sup>th</sup>, 12<sup>th</sup>, and 19<sup>th</sup> (6:30-9:30pm)
  - Draft Day Performance- April 26<sup>th</sup>- Time TBD
  - Mini Camp- April 20-22, 2012
  - Photo Shoot- May 12<sup>th</sup>- All day; May 22<sup>nd</sup> afternoon, evening
  - Optional: All-Pro dance camp- June 30-July 1st

### **Audition Process**

#### **Saturday**

- Saturday will consist of three phases in the audition process.  
Registration- 12-1:00pm. Auditions will begin promptly at 1:00 pm
- Round One
    - All applicants will be taken through a warm-up and taught a basic across the floor combination.
    - The applicants will do the across the floor combination four at a time. Judges will be looking for basic dance technique and a physically fit physique. Upon completion of the combination applicants asked to proceed to the next round will be given a ticket. These candidates take the ticket to the registration table to receive an audition number for the next round.
  - Round Two
    - The remaining applicants will learn a 6-8 count dance combination to be performed in groups of 3.
    - Judges will be looking for strong performance skills, dance ability, and overall appearance.
  - Round Three
    - Applicants selected after round two will learn a one-minute dance routine that will be performed in front of the judges on Sunday. Participants who qualify for this round should expect to end the day around 7:00pm. However, many participants end up staying later to practice the routine.
    - The audition routine will include the following technical skills:
      - Kick
      - Turns
      - Leaps

#### **Sunday**

- Sunday will consist of business interviews and a final dance audition.
- 8:00-11:00 Dance Audition
    - Applicants will review the dance combination taught on Saturday.
    - The routine will be performed in groups of three for a panel judges. The panel of judges will include a combination of sponsors, employees of the Cardinals, dancers, and members of the community. Judges will be looking for knowledge of material,

strong dance technique, performance skills, and overall appearance. Finalists will be selected upon completion of round three.

- Finals Week (March 25<sup>th</sup>-28<sup>th</sup>)
  - 12:00-3:00- Panel Interviews
    - Applicants will participate in a panel interview that will consist of approximately 8 applicants and 8 judges. Business attire is appropriate and applicants are asked to bring a copy of their business resume.
  - The schedule for finals will be as follows:

Tuesday (March 27 <sup>th</sup> )	Practice 6:30-8:00 p.m.
Wednesday (March 28 <sup>th</sup> )	Agility Testing 6:30pm

\*\*Practices and testing will take place at the Cardinals training facility (8701 S Hardy drive, Tempe, Az.)
  - Strength and endurance is an important part of the Cardinals cheerleader program. All applicants will be evaluated on the following skills as part of the agility testing:
    - 1 mile run
    - 100 sprint
    - 1 minute worth of push-ups
    - 1 minute worth of sit-ups
    - 1 plank hold
    - Right and Left Leg splits

## WAIVER AND RELEASE

WHEREAS, I, \_\_\_\_\_, am about to participate in a tryout (the "Tryout") for a position as a cheerleader for the Arizona Cardinals football team at University of Phoenix Stadium in Glendale, Arizona and/or the Arizona Cardinals Training Facility in Tempe, Arizona during February, March, and April 2012, and whereas I am doing so entirely upon my own initiative, risk, and responsibility; now therefore, in consideration of receiving permission from Arizona Cardinals Football Club LLC, a Delaware limited liability company, d/b/a/ Arizona Cardinals ("Cardinals"), to participate in the Tryout, I hereby release, waive, and discharge the National Football League (the "NFL"), the Cardinals, and the shareholders, owners, directors, officers, employees, agents, servants and affiliates of the NFL and the Cardinals from any and all liability, claims, demands, actions, and causes of action whatsoever arising out of or related to any loss, damage, or injury, including death, that may be sustained by me from any cause whatsoever while on the Tryout premises and/or during the Tryout.

I am duly aware of the risks and possibility of physical injury and damage to my person inherent in the Tryout, and I enter upon the Tryout premises knowing their present condition and knowing that physical injury and damage to my person may be occasioned by or may occur from many causes at the Tryout, including but not limited to my own physical defects (of which I may not be aware) and negligence of other Tryout candidates. I voluntarily hereby assume all risk of loss, danger, or injury, including death, from any cause whatsoever that may be sustained by me in, on, or upon the said premises, at and during the Tryout.

This Waiver and Release shall be binding upon my successors, assigns, distributees, heirs, next of kin, executors, and administrators.

In signing this Waiver and Release, I hereby acknowledge and represent:

- A. That I have read this Waiver and Release, understand it, and sign it voluntarily.
- B. That I am eighteen (18) years of age or over and have the legal capacity to execute this Waiver and Release and to make the representations, waivers, assumptions, and releases herein contained.
- C. I am not an agent, servant, or employee of the Cardinals.

I represent that I am in good health and sound physical condition, and that I have no physical defects, latent or patent, and I expressly waive any right I may have to a physical examination prior to, at, during, or following the Tryout.

I agree to pay all attorney's fees and costs incurred by any individual or entity covered by this Waiver and Release in enforcing this Waiver and Release against me. I further agree that this Waiver and Release shall be subject to, and interpreted according to, the laws of the State of Arizona.
